

# Permitted Uses Zoning District: D3 or Downtown 1 (DT-1), Downtown 2 (DT-2), Downtown 3 (DT-3)

**Downtown - 1, Downtown - 2, and Downtown - 3**: A transition area between the downtown and the surrounding residential areas where a wide range of retail, office, residential, and public uses are permitted. A balance of new development with the maintenance and renovation of existing buildings is anticipated, and where development and redevelopment consistent with the established historic and urban design character is encouraged.
